

## MESSAGE FROM THE PRESIDENT

I hope everyone has survived the winter and is doing well. For this month's newsletter, I asked for help from some of the CAGE Officers and Board of Directors. The intent is to provide more specific information to the membership in regard to the Officer or Director activities. So here we go.

### Mark Vessely – Treasurer's Report

The CAGE financial position is stable with a reserve to cover several months of expenses if necessary. In 2009, CAGE was able to continue building a reserve account that can be utilized to cover minor liabilities, planning for annual seminars, and scholarship. Regarding liabilities, lunches tend to be breakeven or a slight loss on a monthly basis. One remedy to this is for our membership to RSVP before the deadline and also **to honor their RSVP**. In 2009, we subsidized approximately \$2,000 for lunches for the year. This is because we are required to provide an estimate of lunch attendance prior to the meeting so any last minute absences are a liability to CAGE. Conversely, the recent L-Pile class and golf and sporting clay tournaments generated a positive cash flow to offset this loss. In this year CAGE will not renew our ASFE Regional Organization status which will be a savings of \$5,000. Additionally, we plan to continue building the reserve balance in 2010 by continuing the annual seminar and tournaments, generating income from the website, and reducing the uncertainty associated with lunch meeting attendance. At the summer Board meeting, we will discuss our financial strategy among the current and past board members to ensure that our funds meet the goal of advancing the local geotechnical practice.

### Andy Garner – QBS Report

CAGE continues to support QBS Colorado. For those who don't know, QBS Colorado is a 9-person group made up of members of AIA-CO, ACEC-CO, NSPE-CO, and CAGE formed to support and promote the use of Qualification-Based Selection (QBS) for design professionals. CAGE Director, Andy Garner is our representative on the QBS Colorado board. Andy has taken on "Outreach" as his focus area for the group. Part of this included setting up the semi-annual QBS Breakfast Forum in October 2009. Approximately 50 attendees from public agencies and private firms listened to Public Works officials describe their success stories using QBS and give ideas about how to implement QBS for procurement of engineering and architectural services. Other outreach activities include a recent presentation for a group of geotechnical engineers in northern Colorado (they've dubbed themselves NOCOGEO), upcoming presentations to students at UC-Denver, UC-Boulder, and CSU, a booth at the NPSE E-week conference, and a QBS break-out session at the APWA management conference. Andy also produced the QBS Colorado Winter newsletter where you can find all the latest on these and other activities, such as their help for "Using QBS for Small Projects" or their RFP "Watchdog" activities.
